### **NSGC's Strategic Initiatives**

- Strategic Initiative #1 Expand access to genetic counseling services by actively pursuing reimbursement for Certified Genetic Counselors
- Strategic Initiative #2 To promote and organizational culture that will enable NSGC to adapt to the evolving needs of Genetic Counselors
- Strategic Initiative #3 Position Genetic Counselors as key players in the integration of genetics across the healthcare spectrum

### Strategic Initiative #1: Federal Effort

- Drafted federal legislation and sent through legislative counsel
- Leadership has met with various members of House and Senate throughout the year to pursue sponsorship of our bill
- Currently pursuing sponsorship by Rep. Louise Slaughter, sponsor of GINA
- Participated in Genetic Alliance "Hill Day" and provided information on genetic counselors and actively promoted NSGC legislation




#### **Strategic Initiative #1: State Licensure**

- NSGC has provided ongoing guidance to a number of states pursuing licensure and writing licensure rules and regulations.
- 4 states are actively licensing, 6 more are making significant progress and another 8 states have initiated efforts toward achieving licensure.
- Provided state licensure grant awards to assist Washington and Florida, and a rolling grant to Hawaii



### Strategic Initiative #1: GINA Victory!

- Genetic Information Nondescrimination Act passed after 13 years!
- NSGC worked as a member of the Coalition for Genetic Fairness in educating legislators and advocating through the NSGC Grassroots network
- Thank you for your support and strong participation NSGC members and the NSGC Grassroots network answered the call to action and made a difference!





### Strategic Initiative #1: Building on GINA...

- NSGC Grassroots support was critical to this success
- We have established a strong platform for support and advocacy that can be replicated for the NSGC federal bill
- Look for "calls to action" from NSGC as we introduce our bill
- We will need everyone to participate again to ensure success!



### **Strategic Initiative #2: Governance**

- Committees now directly address the annual plan of work as established by our Strategic Plan
- Task Forces working on time-limited projects
- Workgroups utilized by committees to engage additional members and increase involvement in committee projects
- Annual Volunteer/Leadership Development Program session at AEC for second year – includes increased opportunities to network with Committee chairs and get involved

### Strategic Initiative #2: Governance

Volunteer Database a success, but still room for growth:

- Accessed for 13 distinct projects/appointments in 2008
- Some projects involved appointing many volunteers
- Making changes to the form in 2009 to increase effectiveness
- Committee Chairs making appointments from database for 2009
- We are actively using this as a source of volunteers make sure we have your information!



### **Strategic Initiative #2: Nominations and Elections**

- The Governance Evaluation Task Force actively evaluating the 2008 Nominations and Election process
- Saw an increase in nominations, and a large increase in nominees willing to be considered for the ballot
- Concern with member participation rate in the election recognize confusion about election vs. ratification of slate
- 2008 Nomination/Election successful in electing a qualified slate, but will make changes in 2009 to improve both the process and our communication with members



### **Strategic Initiative #2: Membership Enhancements**

- Added two new SIGs in 2008 to meet the needs of Students/New Members and International members
- Over 400 members took advantage of the New Genetic Counselor dues category in 2008, helping these new members stay engaged with NSGC in their first few years of practice
- Significant changes made to the 2008 PSS to enable ease of completion and greater response by members in expanded roles
- Grant/Scholarship opportunities have been further expanded to include Diversity awards, Student scholarship, ational society and Cancer, Prenatal and Psychiatric SIG grants

### **Strategic Initiative #2: Education**

- Traveling Short Courses held in Regions II, IV and VI.
- Online course developed in 2008 for all members, building on the success of the Region V pilot course in 2007
- Conference recordings providing alternative method of accessing AEC and Short Course content
- Through the efforts of Sue Schmerler and the CEU Workgroup, NSGC attained providership for genetic counseling CEUs in 2008.
- In 2008, over 35 Category 1 applications and 151 Category 2 applications have been reviewed by Sue and the 18 CEU Reviewers since April 2008

## **Strategic Initiative #2: External Education and Partnerships**

- NSGC represented on IOM Roundtable on Translating Genomic-Based Research for Health
- NSGC advocated for genetic counselors at key meetings in 2008:
  - AAFP Subcommittee on Genomics
  - NHGRI Population Based Carrier Screening meeting
  - ACMG strategic planning meeting
  - Understanding the Needs of Consumers
  - SACGHS
  - American College of Surgeons Commission on Cancer Conference
- NSGC's liaisons attended meetings and conferences to build relationships and further promote the value of genetic counselors

## **Strategic Initiative #2: External Education and Partnerships**

- Practice Guidelines Subcommittee developed new process for soliciting and approving guidelines
  - Actively seeking topics from membership
  - Additional support for authors
  - Streamlined review process
- Goal is to increase the availability and use of NSGC as a source for genetic counseling practice information



## **Strategic Initiative #2: External Education and Partnerships**

NSGC promoted genetic counselors to the public through a partnership with the documentary, *In the Family* 

- Developed Genetics FAQ for website and DVD
- Thirty NSGC member genetic counselors provided information and resources for viewers through the *In The Family* discussion forum and email
- President, Angela Trepanier presented a workshop at the Genetic Alliance meeting with In the Family director Joanna Rudnick

#### **Strategic Initiative #3: Public Relations**

- PCI has helped NSGC has take a proactive approach to promoting NSGC's key messages in the media:
- 8 National, 8 Regional and 10 Local and 82 online media placements in 2008. Numerous other interviews and media contacts established for future
- Developed key talking points and press releases
- Working on an active media pitch to promote genetic counseling as a growing career in today's tough economy



### **Strategic Initiative #3: Advocacy**

- Provided input to SACGHS regarding future priorities NSGC recommendation was ranked 18<sup>th</sup> out of 80 total suggestions by all SACGHS stakeholders and 5<sup>th</sup> by SACGHS committee members
- Educated various healthcare providers and policy makers on and how genetic counselors can serve as resources, educators and providers in the spectrum of genetic services
- Genetic Counselors will be classified as health care practitioners in the O\*Net database

• Submitted a request to the U.S. Department of Labor for listing in their Standard Occupational Classification

### **Strategic Initiative #3: Research**

- NSGC Research Task Force established to make short and long term recommendations for evidence-based quantitative research to demonstrate the value of genetic counseling
- NSGC Leadership, Task Force and GCASD Committee held discussions with CMS, legislators, primary care providers, AHRQ, NHGRI and others regarding the type of data needed




#### **Investment Account Balances as of September 30, 2008**



### **Journal of Genetic Counseling Data** *From January 1, 2008 and October 15 2008*

- Manuscript submission and processing has remained stable.
  - Over the past 10 months, JOGC editorial office received:
    - 88 new submissions; 9.3 per month average (original research and professional issue manuscripts)
    - 101 manuscripts were sent out for revision
    - 83 revised manuscripts were received and sent out for a second reviewed
  - Average # of days from submission to first decision is 40 (time to publication varies dependent upon time taken to revise)
  - Approximately ½ of submissions were submitted by USA authors; ¼ were from Canada, Australia and UK; ¼ from other countries.



### Journal of Genetic Counseling Highlights

- In September 2008, we started filling the August 2009 issue
- The Journal published a great review article on Cowden Syndrome by Rob Pilarski – this increases the visibility of the journal
- The same issue features an important piece by Alexandra Stern documenting the birth of our profession



### Journal of Genetic Counseling Highlights

- This year, the journal will submit an ISI application
- A list of over 14,000 journals is maintained by the Institute for Scientific Information (ISI). Listing is based on published selection criteria and is an important indicator of journal quality and impact.


